RAIGANJ UNIVERSITY SUMMARY OF ADMISSION POLICY FOR GENERATION OF LIST OF APPLICANTS FOR MBA, SESSION 2023- 24.

The list of applicants and their academic credentials to be displayed in the University Website will be prepared on the basis of the information entered by the applicant, Admission Policy of the University, and the Guidelines issued by the University. The admission based on the Merit Lists published by the University time to time are provisional and are subjected to physical verification of original documents. The admission policy of Raiganj University includes inter alia the followings:

- 1. List of applicants to be generated in order of marks obtained in different public examinations, viz. Madhyamik, Higher Secondary, UG level and following the Reservation Norms published by the appropriate government from time to time.
- 2. The List of applicants is prepared on the basis of percentage (%) of marks obtained by a candidate at Graduation level for all the papers he/ she appeared during the entire UG Program. (For example, in case of an applicant with Hons., appeared in 8 Hons./ Major Papers and 10 other papers, the total number of papers he/ she appears during the UG Program will be (10+8)= 18.)
- **3.** If an applicant submitted a marksheet where **only** total marks of all the papers that he/ she had appeared and the marks obtained by him / her is displayed, then, the same will be considered for preparing the merit list.
- 4. If an applicant submitted a marksheet where both CGPA and percentage of marks or total marks of all the papers that he/ she had appeared and the marks obtained by him / her is displayed, the university will only consider the CGPA and the same will be converted into percentage (%) of marks as per the formula published by the University in the Admission Notification. This is because different universities have different formula for conversion of CGPA Marks into percentage (%) of marks, is as under-

The conversion formula for converting CGPA to the corresponding percentage of marks will be as follows:

X= 10 Y – 4.5 (Where, X = Percentage of Marks, Y = CGPA)

The same formula will be applied for conversion from **CGPA to Percentage (%) of marks** for the applicants who passed from a University declaring marks in CGPA.

- 5. In case of multiple candidates who applied with same % of marks at Graduation level, the following principles are to be followed
 - *a.* If the **applicants are** both from the <u>Home University</u> and **applicants from** <u>different</u> <u>universities other than Home University</u>, the tie will be broken following the % of marks obtained at HS or equivalent, followed by Madhyamik or equivalent and date of birth and in order of alphabets in the name.
 - **b.** If the tie happens between and among the Home University and Other University applicants, the applicant from the Home University will be preferred.
- 6. Normally 80% seats will be for the students of the Raiganj University and remaining 20% seats for other Open to all. This 80% and 20% may be relaxed in case of non- availability of the applicants in either category.
- 7. The MBA admission process will involve the written test i.e. RUMAT (written entrance test) as well as Group Discussion and Personal Interview.
- 8. The MBA Admission Process shall be followed in the manner as under
 - *a*. RUMAT (Written Entrance Test): **50 MCQ** questions with **2 marks** each. There will not be any negative marking in the RUMAT. The particulars of the Written exam is as under-

b. The Scheme for Distribution of marks for candidates qualified for the GD and PI will be as under-

PI and GD: Total Marks 50 (GD- 20 & PI- 30)

c. The **Merit Panel** of the MBA applicants will be prepared on the basis of marks an applicant obtains in GD and PI. In case of tie, the same will be broken considering the

marks an applicant obtained at UG> Higher Secondary or equivalent > Madhyamik or equivalent examinations.

- **9.** Once a student's name appears in the merit list, and he/she fails to take admission within stipulated time, his/her name would not be considered in any subsequent list of the same subject.
- 10. Submission of Blurred Document/ Marksheet may lead to cancellation of the application form.
- **11.** Submission of wrong information will lead to cancellation of the application form at any stage of the admission process.
- 12. The applicants who have appeared in the final semester examinations of the respective programme, will be considered on the basis of the marks obtained by them till their 2nd last Semester. However, such candidates if obtains marks which can jeopardise the merit panel (*deprive the right of next applicant in the queue*) will not be considered for confirmation of admission.
- **13.** In case of submission of multiple applications by an applicant, the 1st application will be considered.
- 14. The students appeared in the Final Exam with back papers in Pass subject/s applying for the admission are required to submit the Passed Marksheet during the verification of documents, failing which will lead to the cancellation of the admission.
- **15.** The verification of documents will be done only when the students report for the classes in due course.
- **16.** All the admissions based on the Merit Lists published by the University are provisional and are subjected to the verification of documents.
- 17. Excepting the MBA applicants, the Prospective students are strictly not allowed in the University Campus during the process of admission. No physical presence is required at the University during the time of admission.
- 18. The MBA applicants are required to be appear in the RUMAT which includes written admission test, GD personal interview in appropriate cases to complete the admission process. Failure to appear in the above stated phases as instructed and notified time to time will not entitle an applicant for the admission to MBA Programme at Raiganj University.
